



## **Regulations of Khon Kaen University on Graduate Education Level A.D. 2007 (Second Revised)**

To ensure that the graduate education level is accurately academically standardized, of high quality, efficiency and agrees with the Announcement of the Ministry of Education on “The Criteria Standardization of the Graduate Study Level Program” and provides adequate educational opportunity; the Regulation of Khon Kaen University on Graduate Education Level B.E. 2548 shall be considered as revised.

With respect to Clause 16(2) and Clause 26 of the Khon Kaen University Act and Khon Kaen University Council at the 4/2007 meeting on June 6, 2007 that sets the regulation as follows:

**Article 1** This set of regulation is called “*Regulations of Khon Kaen University on Graduate Education Level, A.D. 2007 (Second Revised)*”

**Article 2** This set of regulations applies to the graduate education level of all curricula at Khon Kaen University from the academic year 2007 onwards

**Article 3** Denounce clause 16.2 of the Regulations of Khon Kaen University on Graduate Education Level, A.D. 2005 and append the following clause:

“16.2 A lecturer of a program referring to a full time lecturer who is appointed to be responsible for program administration by working as a lecturer and/or Thesis or Independent Study advisor in the whole duration of the program. Each lecturer may belong to only one program but could hold another program in related field.

In case a lecturer belongs to a postgraduate program in the same subject this should be considered as one program according to this regulation”

**Article 4** Denounce clause 22 and 23 of the Regulations of Khon Kaen University on Graduate Education Level, A.D. 2005 and append the following clause:

“*Article 22* A Major Advisor must have the following qualifications

A Major Advisor must be a full time lecturer, hold a Doctoral Degree or equivalent in the field taught or hold an academic position of not lower than an Associate Professor in the field taught or in a related field , and have done research work other than the research which is a part of the study for a degree.

A Co-advisor should be chosen according to the Regulation of Khon Kaen University.

*Article 23* A co-advisor must have the following qualifications:

A co-advisor must be a full time lecturer or an expert who holds the same degree and academic position including experience in research

work as the major advisor. If necessary, the expert can be appointed to be a co-advisor”

**Article 5** Denounce clause 31.4 of the Regulations of Khon Kaen University on Graduate Education Level, A.D. 2005 and append the following clause:  
“31.4 Registration of less or more than specified in articles 31.2 and 31.3 should be mandated in accordance with the Announcement of Graduate School”

**Article 6** Denounce clause 52 of the Regulations of Khon Kaen University on Graduate Education Level, A.D. 2005 and append the following clause:

“*Article 52* The student who is failed as in article 50.2 , he/she is able to request a second examination within 15 days of the examination date, and must complete the examination within 60 days of the first examination date

If the student is failed as in 50.1 , he/she is able to request the second examination within 15 days of the ending date of the revision, and must complete the examination within 60 days of the ending date of the revision.

For both cases, the student has to pay the examination fee as per the faculty’s regulations, if the student does not comply, the student’s status is invalid.

For the second examination attempt, the student remains subject to previous regulations

A petition for Thesis or Independent Study should be according to the Regulation of Khon Kaen University”

**Article 7** Denounce clause 63 of the Regulations of Khon Kaen University on Graduate Education Level, A.D. 2005 and append the following clause:

“*Article 63 Article 54* and *60* shall apply to all students except those who have enrolled before the academic year of 2005 though these students remain subject to the regulations of Khon Kaen University on Graduate study A.D. 2001”

A student of academic year of 2001 and 2002 who has been dismissed from student status for failure to complete study within the allowed time limit and wishes to resign his/her status must submit a resignation within 90 days from the date of the announcement.
